 - a. 2.03 A: IPS3 Wood (wood beams and wood base) Stain (ST-1) to be Sherwin Williams Wood Classics Stain, color from full manufacturer line (matching floor). AND Beams – 2 coats Minwax Helmsman Spar Urethane Satin; Base - 3 coats Minwax Helmsman Spar Urethane Satin. Or equal.
